The Commonwealth of Virginia to Honor Littlepage Montague Williams and John Lord
Gentlemen justices of the County of King William greeting whereas William Watkins and Susanna
his wife have by their indenture of bargain and sale bearing date the 28th day of April 1802 sold and
conveyed unto Isaac Quarles one certain tract or parcel of lands containing by estimation eighty nine
to be the same more or less lying and being in the said County and whereas the said Susannah came
conveniently hither to our County Court of King William to make acknowledgment of the said con-
veyance, therefore we do give unto you or any two or more of you power to examine her privately and
take her acknowledgment concerning the conveyance aforesaid contained in the said Indenture
which is here annexed and we command you that you personally go to the said Susannah and
examine her privately and a part from the said William Watkins her husband concerning
her executing the said Indenture and take her acknowledgment thereof and when
you have examined her as aforesaid and received her acknowledgment that you do truthfully
and plainly certify to us that of us our said Court annexed to this writ Witness Robert Pollard
Clerk of our said Court the 25th day of June 1806 in the 30th year of our foundation
