which payment well and truly to be made by the said Governor
his successors we bind ourselves and every of us our and every of our
executors and administrators jointly and severally by these presents Witness our
hands and seals this 28th day of April 1807 in the 27th year of our
Independence.

the above bound Madison Lipscomb hath obtained a Licence to keep an
Ordinary at Aytles in the County of King William of therefore the
said Madison Lipscomb hath constantly found and provided in his said Ordinary
good whilome and cleanly lodging and diet for Travellers and Stage
holders and provender or pasturage and provender as the season
require for their horses for and during the term of one year from
day of the date of these presents and from thence till the
Court held for the said County of King William and shall not suffer
and permit any unlawful gaming in his house nor on the Sabbath
Day nor upon any Sunday or Festival

This Indenture made the eleventh day of October in the year of our Lord one thousand eight hundred and five between Samuel Parluk of the County of King William in the State of Virginia of the one part and Beverly Robinson of the same County of the other part Witnesseth that the said Samuel for and in consideration of the sum of one dollar of lawful money of Virginia to him in hand paid by the said Beverly the receipt whereof the said Samuel doth hereby acknowledge and for the further consideration of securing to the said Beverly the sum of twenty one pounds twelve shillings and ten pence three farthings of lawful money of Virginia be the said Samuel hath granted bargained and sold and by these presents doth grant bargain and sell unto the said Beverly one bay mare named Vicki with her future increase To have and to hold the said mare with her future increase unto the said Beverly his heirs executors and administrators forever provided nevertheless and the true intent and meaning hereof is any thing herein contained to the contrary notwithstanding that if the said Samuel his heirs executors or administrators do and shall when required or demanded pay to the said Beverly his certain all his heirs executors or assigns the said sum of twenty one pounds twelve shilling and ten pence three farthings with Interest from the date of these presents together with the costs of recording and carrying this Indenture into execution then this Indenture and every thing herein contained shall cease determine and be void and the said Beverly for himself his heirs executors and assigns doth hereby covenant and agree to and with the said Samuel his heirs executors and assigns that the said Samuel his heirs executors and administrators shall and may have hold occupy possess and use the said Mare and her future increase to take and receive the service and profits arising
