sold the said land to Joannah Toz the said Gauthney is willing to convey the same to or for  
said Joannah Toz Now this Indenture witnesseth that for and in consideration of the sum of  
hundred and forty three pounds paid to the said Richard Gauthney by the said John Toz as  
the further consideration of the sum of five shillings paid by the said Joannah Toz unto the  
Richard Gauthney the receipt whereof they the said Richard Gauthney and Charlotte his wife  
doth hereby acknowledge and doth hereby at the request of the said John Toz grant by whom it is  
the said Joannah Toz and by these presents do grant bargain sell release & confirm unto her the  
said Joannah Toz a certain tract of land piece or parcel of land wherein the said Richard  
Gauthney now resides containing One hundred & forty three acres and bounded as follows to wit  
Beginning at a red oak corner with the land of Bennett Tuck and running with the line N 39 E 79 poles  
a maple sapling in a branch another corner with said Tuck thence down the said branch and running  
forty six poles to its confluence with another branch up that branch as it meanders being twenty poles  
to the beginning of said Tucks road the place designated by marked trees on both sides of the road and  
run thence S 40 E 8 27 poles to the mouth of a brook along the line S 87 E 8 34 poles to the end  
thereof thence S 47 E 8 19 poles to a gum tree in a branch just below the confluence of the said  
Tucks road and the public road leading by Sabreys mill and down that branch and meander thirty  
four poles to a gum corner with Thomas Pattersons land thence with his land N 60 W 40 poles to an  
elbow spine then N 85 W 17 1/2 Poles to a red & red oak on the public road then by the said Pattersons  
some times by the said road & some times by the edges as his lands will allow One hundred & fifty one  
pole to his corner in William Jones line thence with Jones line N 39 W 30 pole to bay corner in James  
Toz's line then by his line a ditch ten pole to a white oak corner with Bennett Tuck then by  
his line S 69 E 160 pole to the beginning together with all and singular the privilege and  
appurtenances thereto belonging to said tract and to hold the said tract piece a tract of land  
and premises hereby conveyed and every part and parcel thereof unto her the said Joannah Toz her husband  
affirms for ever in fee simple & unconditioned for himself his heirs executors and administrators further intend  
the said Richard Gauthney doth for himself his heirs executors and administrators further intend  
to agree to and with the the said Joannah Toz his wife Каіуіи that they the said Richard Gauthney
