In Horlon & Benj^a Horlon to bee equally divided between them
my ^{to} sons as y^e afore said

viz my will is that my Negroes worke upon my ^{to} Land untill they are
payd for & after wards such debts fully payd & Comptrolld my
will is that my son John shall have one negro man named Dick
& my son Benj^a one negro man named Tony

viz I Give unto my wth beloved wife Sarah Horlon During her
naturall life one negro man named Peter & one negro woman
named Kate: my ^{to} debts being first payd & y^e afore said
& att^r y^e death of my said wife y^e two negroes to fall unto my two
younger sons as afoe

viz my will is if in case either of these my ^{to} younger sons should die
in their manorily that their ^{to} estate shall bee equally divided
between my two eldest sons W^m & Rob^t

viz I Give unto my son W^m one Cow two hoppers & one calf wth all their increase

viz I Give unto my Daughter Mary one cow & one two year outd hopper & one calf

viz I Give unto my son Rob^t one hopper wth all her increase

viz I Give unto my Daughter Sarah one Cow wth all her increase

viz I Give unto my Daughter Frances one Cow wth all her increase

viz I Give unto my Daughter Eliza: one Cow wth all her increase

viz I Give unto my son In^a one Cow wth all her increase

viz I Give unto my son Benj^a one 3 year outd hopper wth all her increase

viz my will is if the Rest of my personall estate Remaine in y^e hands of my ^{to} wife
During her widowhood but in case she should marrie or att^r her
death my will is if my ^{to} estate bee kept in her custody shall bee equally
divided amongst my ^{to} children

viz my will is if my ^{to} sons shall have y^e benefit of their ^{to} estate both per
sonall & Real when they shall attayne unto y^e age of Sixteene as
afoe the benefit of their Labor

viz I Give unto my wth beloved wife Sarah the Remayning part of my ^{to} ^{to}
Cattle bee they more or less

viz my will is if my son John & my son Benj^a shall have the priviledge
of working their ^{to} Negroes upon my now dwelling plantation untill
they shall attayne unto y^e age of Eighteene

 I give unto my Daughter Eliza: one Cow wth all her increase

 I give unto my son Benj^a one 3 year old heffer wth all her increase

 Lawfull Ex^r of this my Last will & Testament In witness whereof I have
