Appoint this my Last Will & Testaments In Manner & form
Following. First I Commit my Soul into the hands of Almighty
God Who gave it Hoping through the Meritorious Death
and my Blessed Saviour to receive free pardon and remission
of all my Sins. Next I Commit my Body to the Earth
to be buried in a Christian Burial according to the Direction
of my Ex^{ts}. Hereafter named and as to my Small Estate both
Real & personal which ^{God} pleased God to bless me with I give
and bequeath following but first I wish that all those

to Buried in a Christian Burial According to the Direction
of my Ex^{rs} hereafter named and as to my Small Estate both
Real & personal which I ^{have} stated y^e do to this my Will I give
and bequeath following but first I want that all my
Debts Due on Right to any person be Discharged &
fully Satisfied paid within convenient time after my
Decease, and then the Remainder part of my Estate I
give & bequeath in Manner & form as followeth that is to
say -

Item I lend to my well beloved Wife Elizabeth Anderson
During her remaining my Widow all that Land
and plantation whereon I now live containing four
hundred Acres more or less I do intend to my & Wife.

 one Negro Woman Slave Named Letina & her Eight
 Children Together with all their future Increase and as
 the Dearest Marriage of my ~~S~~ Wife my Will &
 Desire is that the ~~S~~ Slave Letina & her Eight Children
 and all their future Increase shall be Equally Divided
 into three parts one third part I Give to my Son Richard
 Anderson or the Survivors of him one third part I
 Give to my Son Michael Anderson or the Survivors of
 him and the Other third part I Give to be Equally
 Divided Amongst the Children of my Daughter
 Judith Dabney to remain my two Sons Richard &
 Michael Anderson and their Heirs Forever and I Give
 and bequeath to my Will beloved Wife Elizabeth

Anderson the following Slaves (Viz) Sarah, Tom,
Judith and her four Children (Viz) Fanny, Sam, Ruth,
Walter and all their future Increase to her and her heirs
forever, also all my whole household and Kitchen
furniture with all the Stocks of Cattle, Hogs, Horses,
and Sheep that is on this Plantation to her and her
heirs forever.

I then I give & bequeath to my well beloved Grand Daughter
Francis Anderson Daughter of Richard & Mary
Anderson, (Viz) one Negroe Woman Slave named
Fanny and her Child named Tom now in my Possession
with her future Increase to her and her heirs forever.

I then I give & bequeath to my well beloved Grand Daughter
Margaret Anderson Daughter of Richard & Mary

Anderson one Negroe Girl Named Lucy now in my Possession
with her full Increase to her & her Heirs forever

I then Give & bequeath to my Well beloved Grand Daughter

Edith Anderson Daughter of Richard & Mary Anderson

one Negroe Boy Named Isaac now in my Possession
to her and her Heirs forever

I then Give & bequeath to my Well beloved Grand Son Richard

Anderson Son of Richard & Mary Anderson one Mutt Bo

Named Abraham now in my Possession to him & his
Heirs forever

I then Give and bequeath to my well beloved Grand Daughter

Carshan Anderson Daughter of Richard & Mary Anderson

one Negroe Boy Named Betty now in my Possession

to her & her Heirs forever

I then I give & bequeath to my Grand Daughter Jane
Anderson Daughter of Richard & Mary Anderson
one Negroe Girl Named Liza now in my Possession
with her future Increase to her & her heirs forever

Then I Give and bequeath to my Grand Daughter
Ann Anderson of Richard & Sarah Anderson
one Negroe Woman Slave Named Doll and her future man
bayer now in my Possession with their future Increase
to him & his heirs forever

Named Selina now in my possession with her future increase
to her & her heirs forever

the following Slaves Viz one Negro Woman Slave
named Molly & her three Children Jeremiah, Mary
& Moses which are now in my possession & one Negro
Girl named Doll now in her Possession with their future
increase to her & her heirs forever

I am I give & bequeath to my Grand Daughter Auley Dabney
Daughter of James & Judith Dabney one Negro woman

Have Nam^d McDore and his child Nam^d Sam now in
my Possession with their future increase to her & her heirs
forever

Now I give and bequeath ^{to} my grand Daughter Ann
Anderson Dabney Daughter of James & Judith Dabney
one Negro Girl named Nanny now in my possession
with her future increase to her and her heirs forever

Now I give and bequeath to my Grand son William Dabney
son of James & Judith Dabney one Negro Boy named Peter and
now in my Possession to him his heirs forever

Now I give & bequeath to my Grand Daughter Mary Dabney
Daughter of James & Judith Dabney one Negro Girl named Lay
now in my possession with her future increase to her & her heirs forever

Now I give & bequeath to my Grand Daughter Phanny Dabney
Daughter of James & Judith Dabney one Negro Girl named

now in my possession with her future increase to her & her heirs forever
I then I give & bequeath to my well beloved son Richard Anderson
the following Slaves (Viz) Jack & Paddy his wife Ned & Hannah
now in my possession with their future increase to him &

I then I give & bequeath to my well beloved son Michael Anderson
the following Slaves (Viz) my two Smiths Daise & Matt
& Smiths Tools and Henry & Charles I also give my son
Michael Anderson after his Mothers Decease the
Tract of Land & Plantation I now live on containing
four hundred acres more or less I also give my son
Michael Anderson Two acres Land & Mill Lyng on
the South Side of Pamunkey River after his Mothers

Then I give & bequeath to my well beloved Daughter Judith
Dabney one Tract of Land I purchased of Owen Dabney
Lying on Taylors Creek Containing 200 & 60 Acres more
or less I also I give my Daughter Judith Dabney the
Following Slaved (Viz) Great Nanny, Pat, Bantox
Adam now in my Possession With their future increase
to her & her heirs forever.

Then I give & bequeath to my well beloved Great Grand Daughter
Ann Thomson Johnson Daughter of Christopher &
Elizabeth Johnson one Negro Boy named Peter
now in my Possession to her & her heirs forever.

Then I give & bequeath to my Grand son Richard Anderson
Son of Michael & Sarah Anderson one Tract of Land
I purchased of David Henderson Containing one hundred
& Eighty Acres Land more or less now in my Possession
to him & his heirs forever.

Item I will that the remainder of my Negroes be equally
Divided into three parts one third part I give to my
son Richard Anderson one third part I give to my son
Michael Anderson & one third part I give to my Daughter
Sarah Dabney To them & their Heirs forever

Item my will is that if any of my said Children
should Lose their Negroes I have left them in this
will before they come of age or married I will that
my son Richard & Michael Anderson & Sarah Dabney
shall pay the Value of any of their Negroes as may
Due to the Child as belongs

Item my will is that my Estate shall not be Appraised
nor my Exrs give Security for their due performan^{ce}
Lastly I Nominate Constitute & Appoint my well
beloved Wife Elizabeth Anderson my son Richard
Anderson & Michael Anderson & my son in law
