revoking and disannulling all other Wills here made & first
I commend my soul into the hands of almighty God & my body
to the earth in a Christian like manner -

Imparsons I desire that my out standing debts be paid &
my debts be paid -

Item I give unto my daughter Elizabeth Pettus Colfax shillings
confirming unto her the property already given
unto her &

Item I give unto my son Joseph Boswell three shillings
confirming unto him the property already given
unto him & his heirs forever

Item I give unto my daughter Ann Raggsdale
three shillings confirming unto her the property
already given unto her and her heirs forever

Item I give my daughter Ann Raggsdale three shillings con-
firming unto her the property already given unto her &
her heirs forever - I give unto my son John Boswell
three shillings confirming unto him all the property already
given to him & to his heirs forever - I give unto my
daughter Susanna Mariable the following named negroes

given to him & to his heirs forever = I give unto my daughter Susanna Marable the following named negroes to wit, Randolph - Lacy & Miley now in her possession together with all the property given & aliened to her in marriage & two other negroes to be aliened to her at the discretion & choice of my beloved wife & to her heirs forever. Item I give unto my three Daughters (to wit, Lucy, Mary & Martha each as they marry) five negroes each as at the discretion of my beloved wife choose likewise to each of them a horse & saddle one feather bed & furniture & one Coff. to them & their heirs forever.

Item I give unto my son William Boswell after the death of my beloved wife the following named negroes to wit, George, Orsburn, Solomon, Esther & Agga with their future increase & one feather bed & furniture - pig head of sheep pig head of hog & two cows & calves to him & his heirs forever.

Item I give to my beloved wife Barbary the following named negroes to wit, Lucy & her child Eunice & Miley, Galuspy - Nancy & Abraham & their increase to her & her heirs forever.

Item I lend unto my beloved wife during her natural life all that part of the tract of land on which I now live lying on the south side of Stoner Road beginning at Daniel & Deborah's house near Peter's old plant patch corner - along the said Road as it meanders to John -

forever. I give unto my three Daughters (to wit, Lucy,
Mary & Martha each as they marry) five negroes each
as at the discretion of my beloved wife choose - likewise
to each of them a horse & saddle one feather bed & furniture
& one staff to them & turn him forever -

I give unto my son William Boswell after the death
of my beloved wife the following named negroes (to wit,
George, Osburn, Solomon, together & cogg with their future
increase & one feather bed & furniture - six head of Sheep
six head of Hogs & two cows & calves to him & his heirs forever

I give to my beloved wife Barbary the following named
Negroes (to wit, Lucy & her child, Emanuel & Molly, Gulaspa,
Nancy & Abraham) to her & her heirs forever -

I give unto my beloved wife during her natural life
all that part of the tract of land on which I now live
lying on the South side of Stoner Road beginning at
Dances & Dabners' corner near the old plantation
corner - along the said Road as it meanders to Johns -

Dancers line to said road - Together with all the portion
of my estate of whatever description not herein named

to this devise I will and give & in full of his debts
& for the maintenance of her self & her three daughters
in and out of wedlock to wit, Lucy, Mary & Martha
the said Mary at the age of 18

I give & bequeath unto my son Wm Boswell the above
named tract of land with all the pertinenances thereto
belonging to him & to his heirs forever. The residue of the above
estate I expressly direct shall after the death of my beloved
wife be equally divided between my six daughters to wit,
Elizabeth Pullen, Charity Almond, Susanna Marable, Lucy
Boswell, Mary Boswell & Martha Boswell to them & their
heirs forever. Lastly I appoint my beloved wife Barbary &
my son Wm Boswell whom he shall be of lawful age executing
& Executor of this my last will & testament - as witness
my hand & seal this 16 April 1821

In Lunenburg County Court the 16 April 1823 The within written
last will & testament of John I Boswell dec'd was presented
into Court & the same was proved by the oaths of two of the
justices thereof and ordered to be recorded - and on the
motion of Barbary Boswell executrix of Wm Boswell executor
therein named who read with accompanying certificate is granted
them for obtaining probate of said will in and form
whereupon they entered into & acknowledged bonds conditioned as

beings to equally divided between my two daughters to wit,
Elizabeth Pullen, Charity Almond, Susanna Marable, Lucy
Boswell, Mary Boswell & Martha Boswell to them & their
heirs forever lastly - I appoint my beloved wife Barbary &
my son Wm Boswell whom he shall be of lawful age executor
& Executor of this my last will & testament - as witness
my hand & seal this 16 April 1821
