In the name of God Amen I Thomas Moore of the County of Westbury  
State of Virginia being in weak and low state of health at present but of a sound  
mind and memory thanks be to almighty God for the same and do make and  
give this my last will and Testament. I Give, devise and dispose of  
my worldly Estate in the following manner and form - I Infirmities  
It is my will and I do Order that all my just debts and funeral Expenses  
be first paid and satisfied. Item, I Give to my beloved Daughter Tabernus  
Hudson One negre Girl called by the name of Winney together with her Increase  
whom and her heirs forever. Item I Give to my son Thomas Moore the  
sum of five Shillings Current money to him and his heirs forever. Item  
I Give to my son Seth Moore five Shillings Current money to him and his  
heirs forever. Item I Give to Daughter Elizabeth Davis five Shillings  
Current money to her and her heirs forever. Item my Will and devise  
is that my negre man called by the name of Popper may choose his  
master among the whole of my Legates but he shall be Valued by three  
honest men of good Judgment at two months Credit and his owner shall  
pay unto my Estate his Valuation to be decided in manner following  
or hereafter mentioned Item I Give to my daughter Priscilla Surin

the seventh part of my Estate hereafter mentioned provided the same  
and shall true hainlefs the Estate of the said Thomas Moore Sen<sup>r</sup>  
in consequence of his being security for her obtaining letters of Administration.  
On the Estate of Elijah Tene died in time of her Widowhood otherwise  
my will is that she my daughter Priscilla Tene shall have the sum  
of five Shillings current money and no more, to her and her heirs forever.  
I give to my Six Children hereafter mentioned to wit George Moore  
Vard Moore South Boyel Nancy Crocker Mary Franklin and Mary  
Wells the balance of my Estate (Exclusion of the legacies before mentioned)  
together with the Increase and the Valuation of the same to be equally  
divided between them six persons as above mentioned in this Clause, and  
provided my daughter Priscilla Tene shall have hainlefs my Estate  
My will is for her to have an Equal proportion with the above mentioned  
Six children of that part of my Estate mentioned in this Clause, to each of  
them and their heirs forever. Now I do hereby constitute and appoint my  
beloved friends Griefing Crocker, George Moore and Hugh Franklin Executors  
of this my last Will and Testament and I do hereby wholly disavow  
and Revoke any other Testamentary Will saying or Granting by me

any ways before mentioned ratifying and confirming this and no other to be my last  
Will and Testament. In Witness whereof I have hereunto set my hand & seal  
this 31<sup>st</sup> day of March 1793
