God to bestow upon me I give and dispose of the same
as followeth -

Item I will that all my Real Estates and Reasonable furniture all
things be first paid and satisfied -

Item I give and bequeath to my Grandchild John Battister
a table, a Kettle and books; the Keys thereto to him
and his heirs forever -

Item I will that my two Wggers shall be employed to work
for the maintenance of John Darr, Sarah Darr, and
William Darr, together with all the Rent and Profits of
my Estate Goods and Chattels untill the said John Darr
my Grandchild shall come to the Age of twenty years

at follow the -
Now I will that all my best Dolls and Reasonable for all
things be first paid and satisfied -

Now I give and bequeath to my Grandchild John Dancy
a table, a Kettle and books; the King's Arms to him
and his heirs forever -

Now I will that my two Wives shall be employed to Work
for the maintenance of John Dancy Sarah Dancy and
William Dancy, together with all the stock and the price of
my Estate Goods and Chattels untill the said John Dancy
my Grandchild shall come to the Age of twenty one
years, and then I give and bequeath the said two
Wives Goods and Chattels of what nature or kind
soever unto the said John Dancy his heirs and assigns
forever he paying to the said Sarah Dancy and William
Dancy their full parts and portions of all the Estate
Left to them by their father John Dancy deceased
at they are Heirs of him that he or of his Heirs
to demand the same. And it is my will that if
my Daughter or her legal Heirs shall be
said Grandchild's Heirs with all my power give
the plantation of some five hundred acres of land
lying adjacent to the said John Dancy's land

(C) The said John Davis shall have of my land the
present crop to be employed to feed the said children;
only a ~~the~~ Road of Down for the said land. And he
