Ann Haines servant to Mr. Michael Musgrove acknowledges herself willing to serve her said master five years from her arrival in the country. 2 Apr. 1688, p. 343.

Richard Harrison servant to Mr. Mathew Kemp came into court and produced an indenture whereby he the said Harrison was bound to serve seven years but the said Harrison notwithstanding voluntarily & freely offers & acknowledges to serve his said master the full term of eight years from his arrival into this country. 5 Nov. 1688, p. 368.

George Roades servant to Ralph Wormley Esq. coming into this country in the ship *Steven & Edward* is adjudged 13 years of age. 7 Jan. 1688/9, p. 386.

James Dowlen servant to Ralph Wormley Esq. coming into this country in the ship *Resalu* [?] of White Haven is adjudged 18 years of age. 7 Jan. 1688/9, p. 386.

James Cullbrath servant to Ralph Wormeley Esq. coming into this country in the ship *Susanna* without indentures is adjudged 16 years of age. 1 Sept. 1690, p. 481.

Thomas Keatting servant to Edward Clark coming into this country in the *St. Thomas* of London is adjudged 10 years of age. 9 Oct. 1691, p. 525.

James Clark servant to Mr. Christopher Robinson being imported in the ship *Speedwell* of London is adjudged 16 years of age. 7 Dec. 1691, p. 534.

William Humphreys servant to Capt. Richard Willis which came into this country in the ship *Vyne* of Dublin is adjudged 12 years of age. 8 May 1693, p. 632.

The indenture between Margaret Devorage of Upton upon Severn in the county of Westminster [*sic*] and James Trewolla of London merchant dated 4 April 1689 quoted *in toto*. The witnesses were William Trassel and George Carmin[?]. Margaret Devorage said she was 19 years of age, single, and unmarried before Denis Russell, Mayor of the Town of Falmouth in Cornwall, on 4 April 1689. In open court William Chadwick aged about 21 years stated that in 1688/9 he came to the colony of Virginia in the [?] *Merchant*, Capt. Thomas Barwell commander, and that he saw Margaret Devorage's indentures several times on board. His uncle was a witness to the said indenture. 7 Aug. 1693, pp. 647-49.

Patrick Sallavon servant to John Fenney which came in the ship *Providence* of Dublin is adjudged 13 years of age. 8 May 1699, p. 280.

Bryon Ganing[?] servant to Thomas Gilley which came in the ship *Providence* of Dublin is adjudged 13 years of age. 8 May 1699, p. 280.

Thomas Williams servant to William Churchill, gent., which came in the ship *Elizabeth and Mary* is adjudged 11 years of age, only in payment of levies, the said Williams having indentures. 8 May 1699, p. 280.

Garret Dillion servant to Peter Chilton which came in the ship *Providence* of Dublin is adjudged 18 years of age, the said Garret Dillon alledging he had indenture for five years but were lost and the same not appearing,

he is by the court adjudged as above. 8 May 1699, p. 280.

James Harris servant to Paul Thilman which came in the ship *Loyalty* is adjudged 14 years of age. 5 June 699, p. 286.

Thomas Stapleton servant to Maj. Robert Dudley which came in the ship *Expectation* Brigenteene is adjudged 18 years of age. 4 Mar. 1699/1700, p. 323.

William Raynes servant to Maj. Robert Dudley which came in the ship *Expectation* Briginteene is adjudged 12 years of age. 4 Mar. 1699/1700, p. 323.

Christopher Kellsha a servant to Thomas Alliman came into court and acknowledged he was to serve seven years by indenture from the 15th day of March 1698 the time of his arrival into this country which said indenture was lost; and John Landsford and Rev. Hartley did make oath upon the Holy Evangelist that they had seen the said indenture which is now lost and that he the said Christopher Kellsha was to serve seven years by the same. 6 May 1700, p. 342.
