Middlesex County was formed from Lancaster in 1669 and its area has remained unchanged since then. Will Book 1713-34 is much worn and portions of the pages a missing. Whenever possible the missing words and phr have been supplied from the Court Order Books and oth sources.

Smith's where the deced. was about an hour before the signing of the said will by the testator he observed that when nobody talked to him he spoke but did not talk sensibly, but when anybody spoke to him he talked sensibly and gave rational answers and that when Capn. Smith asked him if he would sign his will he answered he did not care and thereupon signed and sealed his will and declared it to be his last will. This deponent had no other reason to believe the said deced. was not in perfect sen[se] and memory than what he hath above Howard Williams declared.
