mond and State of Virginia, being of sound mind and memory,  
do make, publish and declare, this to be my last Will and Testament  
in manner and form following, to wit.  
1<sup>st</sup>. I give to my son Dand Miller, all the Land and plantation where on  
I know live, to him his heirs and assigns forever.  
2<sup>nd</sup>. I give to my son James A Miller, all my land called by the name of  
Cary Porter, land, to him his heirs and assigns forever.  
3<sup>rd</sup>. I give to my two Daughters Nancy and Elizabeth Miller all that  
tract of land by the name of the Price land, to them their heirs and  
assigns forever.  
4<sup>th</sup>. I give to my son Elisha and James A + Dand. and my Daughter  
Nancy and Elizabeth and Mary Ann Morgan, all the remaining  
part of my estate, be it of what nature or kind to them their

heirs and assigns forever.  
 5th. I appoint my son James A. Miller Executor of this my last will and Testament, hereby re-  
 voking all former wills by me made. In witness whereof I have hereunto subscribed my name  
 and affixed my seal, this 4th day of January one thousand eight hundred & sixty eight.
