Your Commissioner reports to Court that Wm. Eley Sheriff, & Committee of Edward H. Darden dec'd has exhibited before him a statement of all money's received by the said Wm. Eley or with which he had become chargeable or had disbursed, during the periods embraced in the foregoing account together with the vouchers in support of the disbursements. That he finds a balance of \$856.72 to be due by the said Wm. Eley to the said Estate, on the 14th day of October 1866, with interest thereon from that day.
