

I, Garrison Cress, of the County of Nansemond, in the State of Virginia, hereby revoking all former wills by me at any time made, do hereby make my last will and testament, as follows:

1. I desire that my body may be decently buried, without needless expense, and that a grave stone be erected at my grave, which shall be in keeping with my estate and station in life.

2. I direct that my just debts be paid as soon after my death as conveniently may be, and to that end charge my whole estate, real and personal, with the same.

3. I give and devise to my wife Luvenia Cress, for and during her life, as long as she remains my widow, my farm in Nansemond County, Virginia, upon which I now reside (my home place) together with all household and kitchen furniture, carts, wagons, buggies, harness, agricultural and other implements, and goods of all kind used upon the said land; growing crops, and provisions of all sorts laid in for family consumption. Upon the death or marriage of my wife, I give and devise the above described property to my grand son Lezier Cress. But if my grand son Lezier Cress should die without lawful issue, in that event I devise the said land to my relatives Clinton Dillard, Elijah Brown and John H. Helland, share and share alike.

4. I give and devise to my daughter Louisa, wife of Wiley J. Tharpe Jr., in fee simple, my farm in Nansemond County, Virginia known as the Elisha Tyler farm.

5. I give and devise to my daughter Louisa (wife of Wiley J. Tharpe, Jr.) and my grand son Lezier Cress, in fee simple, share and share alike, my one half interest in the lot and store house, in the Town of Helland, Nansemond County, Virginia.

6. I direct that my business affairs that I may have at the time of my death, be wound up as quickly as possible after my death and converted into money. I also direct that all my horses, mules, cattle, hogs and stock of every kind, be sold and converted into money.

7. I give and bequeath to my wife Luvenia Cress, my daughter Louisa Tharps and my grand son Lezier Cress, all the cash money I may have at the time of my death, including the cash derived from the sale of articles mentioned in the 6th clause of this my will, after the payment of my debts and funeral expenses, to be divided equally, each to receive one third.

8. All the rest and residue of my estate, of every kind and character, I give to my daughter Louisa Tharps.

9 I name and appoint Luvenia Cress, of Nansemond County Virginia, the executrix of this, my last will and testament, and request that she may be allowed to qualify as such by giving bond without security.

I give and bequeath to my wife Luvenia Cress, my daughter Leuisa Tharps and my grand son Lezier Cress, all the cash money I may have at the time of my death, including the cash derived from the sale of articles mentioned in the 6th clause of this my will, after the payment of my debts and funeral expenses, to be divided equally, each to receive one third.
