I, George C. Wilkins, of the County of Nansemond and State of Virginia, being of sound mind and disposing memory do hereby make publish and declare this my last will and testament in the manner and form following hereby revoking all former Wills by me at any time heretofore made.

First. I desire and direct after my death my body be given a decent Christian burial and all my funeral expenses to be paid.

Second. I loan to my beloved wife, Peggie Ann Wilkins, my entire estate consisting of my farm on which I now reside containing fifty-five (55) acres, more or less, bounded as follows: on the East by the lands of John F. Brinkley's estate, on the South by the lands of Fred Brinkley and others, on the West by the lands of Thomas J. Brinkley, deceased, and on the North by Benjamin Wilkins and all of my chattel property of every kind and description during her natural life and after her death I give to my son Wallace Wilkins one hundred dollars in cash to be paid to him by my son W. T. Wilkins.

And I give and bequeath to my son Willie T. Wilkins after paying one hundred dollars in cash to Wallace Wilkins as above directed and after the death of my wife Peggie Ann Wilkins my farm on which I now reside as above described in this Will., Also all of my chattel estate of every kind and description except my house-hold and kitchen furniture to be hereafter disposed of.

I give to my daughter Ludie Baines, all of my household and kitchen furniture after the death of my wife Peggie Ann Wilkins of every sort kind and description meaning all the property in my house not already owned by my son Willie T. Wilkins except the bed and stead used by me and my wife which I give to my son Willie T. Wilkins and not including one bed already given him.
