

Isaac Lee's
Will.

In the name of God, Amen. I Isaac Lee, of Hansemanob County, State of Virgin-
ia, being feeble in body, but of sound and disposing mind, do make this to be my last
will and testament as follows: Firstly I give and bequeath unto my daughter in law
Mary Eliza Lee, Widow of Rich^d H Lee dec^d. one cow and calf, sow and pigs and one years
provisions for herself only. Secondly, I also loan unto my daughter in law Mary Eliza
Lee, widow of Rich^d H Lee dec^d. a certain portion of my land as down interest, during
her life, described as follows: Commencing near Elisha Holland (on his line) at a
marked tree, western side of my plantation, running thence to the corner of my fields
and along the line of the fence, by the west gate, on to the head of the lane to a large
pine (an old line tree) thence down said lane (Eastwardly) to a large forked, persim-
mon tree, near the further end of the lane, thence a North west course, straight across
the plantation to the line dividing the same and the land of Henry Howell, and
thence up my line West. through its various directions to the beginning, and the build-
ings thereupon. Thirdly, I give and bequeath unto my grand children James Wilson
Lee and Richard Octavius Lee, children of said Rich^d H Lee dec^d. the proceeds of the
sale of the Holland tract of land and the lands of which I did possessed unequal
proportions, and also one half of my Chattel estate; and in the event of the
death of either of said children before he arrives at lawful age, his portion, shall
go to the surviving brother, and if they shall both die before they arrive at law-
ful age, it is ~~my~~ will & desire that the whole be given to my daughter Margaret A,
Norfleet, wife of Jno Norfleet Jr. Fourthly and lastly: I give and bequeath unto
my daughter Margaret A Norfleet, wife of John Norfleet Jr. the other or remaining
half of my Chattel estate. And I hereby nominate and appoint my friend
James Barnes and my son in law John Norfleet Jr. to be Executors, of this my
last will and testament. In witness whereof I hereunto set my hand and

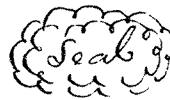

Whereas, I, Isaac Lee, have made & duly executed my last will and
testament in writing, bearing date 31st day of May 1866 - Now I do here-
by declare this present writing to be a Codicil to my said will & direct same
to be taken as a part thereof; and I do hereby give and bequeath First
unto Peter Lee (Colo) fifteen acres of land surrounding and of course in-
cluding the house in which he now lives, during his life only, and after
his death, to be disposed of as the foregoing will directs. Second, I give
and bequeath unto Pleasant Lee (Colo) ten acres of land surrounding
of course including the house in which she now lives, for and during
her life only, and after her death, it is my will that it be disposed as
will directs. In witness whereof, to this present writing, which I declare
to a Codicil to my last will and testament, I have hereunto set my
hand and seal this the 20th day of February 1869.

R. Daughtry and Thomas H. Barnes, subscribing witnesses hereto, and was thereupon ordered to be recorded. And on the motion of James Barnes, one of the Executors, named in the said will, who made oath as the law directs and entered into a bond in the penalty of Ten thousand Dollars, conditioned according to law, with Thomas H. Barnes and Edward R. Daughtry his sureties thereon (who justified on oath as their sufficiency and which said bond being acknowledged by the obligors therein is ordered to be recorded) Certificate is granted the said James Barnes, for obtaining a probate of the said will and Codicil in due form. John Norfleet Jr. the other Executor named in the said will having appeared in open Court and refused to take upon himself the burden of the execution thereof.

Edward Whitfield's In the Name of God amen, I Edward Whitfield, being of sound mind and disposing Will. memory and calling to mind the uncertainty of human life do make and appoint this to be my last will and Testament in manner and form as follows. To wit. 1st. I lend unto Sally Jones, during her natural life all my estate including both lands and chattels of every description. 2nd. After the death of the said Sally Jones, I give and bequeath unto my Daughters Sarah Jones (alias Whitfield) Mila Jones (alias Whitfield) and Rebecca Pierce, and to their heirs forever, all my Estate of Every Kind including lands and chattel property of every description in equal shares and portions, with this provision, that should my son Jordan ^{Jones} (alias Whitfield) who is now absent, ever return that he shall have a share equal with the above named legatees. And I do hereby revoke all former wills made by me at any time and declare this to be my last will and Testament. In witness of the said Edward Whitfield have set my hand and Seal this 31st day of January in the year 1868.
