I say unto my son Job and to his heirs for ever. Item. I give and bequeath unto my son Meredith Holland my other plantation and one hundred and fifty acres of land, also one negro boy named Jesse, and one negro girl named Rashel. I say unto my son Meredith and his heirs for ever. item. I give and bequeath unto my son Elijah "olland, one negro man named Charles and my carpenters tools, and one boy named Jacob and one girl named Morrea. I say unto my son Elijah and to his heir: forever. Item. I give and bequeath unto my daughter bathsheba GAT Watson one negro boy named Sambo, and one girl named Rose. - say unto my daughter Bathsheba Watson to her and her heirs for ever. item. I give and bequeath unto my daughter Betsy holland one negro boy named wills and one girl named Fan. - say unto my daughter betsy and to her heirs for ever. item. - give and bequeath unto my daughter Polly Holland one negro named Ned and one named Cate. I say unto my daughter rolly to her and her heirs forever. Ltem: I leave all the remainder or part of my estate, goods, chattles, and credits to Mary my wife her lifetime, not to be destroyed, and after my decease to be justly and equally divided among my children, say Job, Meredith, Elijah, Betsy, Folly Hollands, and bathsheba Watson. I nominate and appoint wary my wife and my son Job molland to be my whole and sole executors, to this my last

Will and Testament revoking, making void all other will or wills heretofore made by me, establishing this and no other to be my last will and Testament.
