LAST WILL AND TESTAMENT OF JOSEPH FRANK HOLLAND

I, Joseph Frank Holland of Nansemond County, Virginia, hereby revoking all former wills by me at any time made, do hereby make my last will and testament as follows:

1st I direct that all my just debts shall be paid first.

2nd I give and bequeath unto my beloved wife Cherrie M. Holland all my land, all stock (animals), chattel estate all crops on farm.

3rd. I direct that all money in Bank of Holland, all bonds and notes, my stock in bank of Holland, stock in Woodman Hall and stock in Glenwood Park Norfolk, Va., all stock certificates be sold to the highest bidder in front of the Bank of Holland and be equally divided between my wife Cherrie M. Holland, and my children as follows: Gertie L. Ellis, Suffolk Va., R.D. #3, Ola M. Byrd, Holland, Va., R.D. #1, Eley F. Holland, Holland, Va., R.D. #3 Peahontas Whitfield, Holland, Va., R.D. #1. Jesse L. Holland, Holland, Va., R.D. #3, Susie B. Finch Lawrenceville, Va., and Ava A. Holland, Holland, Va., R.D. #1.

4th. I name and appoint my wife Cherrie M. Holland and my son Eley F. Holland my executors of this my will and request that they be allowed to qualify and give bond without security.

In the Clerk's Office of the Circuit Court of Nansemond County, the 5th day of September, 1919.
