 Second: I will, give and bequeath to my said son, Raleigh Keeter, all my household effects live stock, provisions, farm chattels and all other personal estate of every description that I may have at the time of my death.

And lastly, I nominate and appoint my said son, Raleigh Keeter, sole Executor of this, my last will and testament and request of the Honorable Court before whom this will is probated that no security be required of him.
