I, Mary J. Wright, of Churchland, Norfolk County, Virginia, being of sound and disposing mind and memory, do hereby make and declare this to be my last will and testament, hereby revoking all other wills by me at any time made.

First: I desire all my just debts, if I shall owe any at my death, and the reasonable costs and expenses attendant upon my death and proper burial to be paid.

Second: I give and bequeath to my beloved daughter, Annie S. Wright, any and all money that I may have in Bank or in hand at the time of my death, and also all my household and kitchen furniture and furnishings, including my books, pictures and plate, of which, I desire no inventory or appraisement to be made.

Third: I give and devise to my beloved daughter, Annie S. Wright, as her own absolutely and in fee simple, my home at Churchland, Virginia, at which I now live, including the lot of land on which my house stands and the two other lots of land adjoining that lot, being in all about six (6) acres of land.

Fourth: All the rest and residue of my estate, real personal particularly including all and whatever interest in the estate of my late husband, T. J. Wright, I may have I give, devise and bequeath to my beloved son, T. J. Wright, Jr., and my beloved daughter, Annie S. Wright, absolutely and in fee simple, share and share alike.

Fifth: I appoint my daughter, Annie S. Wright, Executrix of this my will and having perfect confidence in her judgment and integrity, I request that no security be required of her as such Executrix.
