Will

I, Mattie Wills of the County of Isle of Wight and State of Virginia, do make this writing my last will and testament in the following manner to-wit:

1st. I give to my daughter Gracie Lee Gay, my piano, one large feather bed, bolster and pillows, one pair sheets one pair blankets two quilts, one set of the bed room furniture, two large silver table spoons, the old arm rocking chair that was her fathers also my china cups & saucers, tea pot, sugar dish, bowl, and cream pitcher, wardrobe and fifty dollars in money.

2nd. I give to my daughter Nannie L. McClenny, my silver ladle, the cherry rocking chair that her father left, the old beaureau that was her grandmother's (Mrs. Duke) china plates, and ice cream saucers, clock that was her fathers and fifty dollars in money.

3rd. To my daughter Lucy Thelma Wills I give one half of what household and kitchen furniture is left after Nannie and Gracie get articles that are heretofore mentioned in this writing, also one half of the chattel and real estate. If there is any money, or bonds, Lucy Thelma is to have one half. If Lucy Thelma should die without a lawful heir of her body then Manie Ethel Wills must have what she leaves.

4th. To my daughter Manie Ethel Wills I give one half of what household and kitchen furniture is left after Nannie and Gracie get articles heretofore mentioned in this writing, also half of the chattel and real estate, If there are any bonds or money Manie Ethel is to have one half. If Manie Ethel should die without a lawful heir of her body, then Lucy Thelma must have what she leaves, If Manie Ethel and Lucy Thelma should both die without any lawful heir then Nannie McClenny and Gracie Lee Gay or their lawful heirs must have what they leave. I also appoint my friends Robert A. Edwards as my administrator with the property security.
