


Rebecca J. Norfleet's Will. I Rebecca J. Norfleet, of the County of Nansmond and State of Virginia, being weak in body, but of sound mind and memory, do make this my last will and testament in the following manner viz: First I give and bequeath to my sister Martha J. Council's children, the land which I received from my father's estate, consisting of a part of the home plantation, to them and to their heirs forever. Secondly, I also give and bequeath to my two nephews here named all of my Challed estate, after paying my burial expenses, and other just debts, to them and to their heirs forever. and Thirdly, I leave my Brother Jno. Norfleet to sell such of my property as he may think best to pay my burial expenses, and other debts. In testimony whereof I hereunto subscribe my name and affix my seal, on this fourteenth day of May in the year of our Lord, one thousand eight hundred and sixty eight.

Signed, sealed, published & declared by Rebecca J. Norfleet the Testator to her last will and testament in our presence we believing her to be in her perfect senses & memory, and signing our names at her request as witnesses.

uary 1870.

This Last will and Testament of Rebecca J. Norfleet, late of this County de-
ceased, was this day fully proved by the oaths of Benjamin G. Porter and Henry
A. Rawls, the subscribing witnesses hereto, and was thereupon ordered to be
recorded, and John Norfleet the Executor, named in the said Will, in open
Court refused to take upon himself the burden of the execution thereof. -
Whereupon, on the motion of Benjamin G. Porter, who made oath, as the
Law directs and entered into a bond in the penalty of Two Hundred -
Dollars, conditioned according to Law, with James B. Porter his Surety in
therein, (who justified on oath, as to his sufficiency and which said bond being
acknowledged by the obligors therein is ordered to be recorded) Certificate, is
granted the said Benjamin G. Porter, in obtaining letters of administra-
tion on the Estate of the said Rebecca J. Norfleet deceased with the said
will annexed in due form.
