Shelly Lynn Doles and James Blanton Doles.

3rd: In the event of my wife's death or marriage, I will that my three youngest
children Lizzie Mary, Shelly Lynn and James Blanton Doles, shall each have One
Thousand Dollars, the balance of my property to be equally divided between all
of my children.

4th: I hereby nominate, constitute and appoint my beloved wife, Lizzie Doles
as Executrix of this my last Will and Testament, and I hereby request the Court
to allow her to qualify without security,
