I desire and direct that all debts that I now owe shall be paid out of the crop made on the farm, except Doctor's bill and burial expenses.

Gard ner, equally to the two, all of the farm whereon I now live, known as the "Hare place" and contains 572 acres of land, more or less, including all the timber on the farm, all of the stock, including all the hogs, cattle, sheep, all of the horses and mules, now 3 head of horses and 2 head of mules, all of the catts, wagon and farming utensils of all kinds and descriptions, also all the crop that may be made on the farm, be be theirs in fee simple.

Item 2d. Henry Grady Gardner must pay to George M. Gardner \$350.00 for George's one half interest in the home buildings to have a reasonable time to pay same, not to exceed 2 years without interest.
