

I, W. S. Holland, being of sound mind and disposing mind do make and ordain this my last will and testament hereby revoking all former wills or codicils made by me.

Item I. I desire that all my just debts be paid.

Item II. I give and bequeath to my son Hugh L. Holland all my law books and office furniture.

Item III. I give and bequeath to my son William S. Holland, Jr., the sum of fifteen hundred (\$1500.00) dollars.

Item IV. I give and bequeath to my daughter M. Louise Holland one thousand dollars (\$1000.00).

Item V. All the residue of my property, subject to my wife's dower, I give, devise and bequeath to my four children, Charlyle P. Holland, Hugh L. Holland, M. Louise Holland and William S. Holland, Jr., share and share alike.

Item VI. As my wife Alice B. P. Holland is already possessed of the lot on which my office is situated, I make no provision for her other than her dower.

Item. I desire that all advances either in money or supplies that have heretofore been made to Carlyle P. Holland since his marriage or that may hereafter be made to him shall be charged against his share of my estate.

Item VIII. I nominate and appoint my brother J. Peter Holland executor of this my will with power and authority to sell such land or lands as in his judgment may be best, giving proper deeds therefor and distributing the proceeds in accordance with the provision of this will, said sales to be made either privately or at public auction.

Item IX. I give and bequeath to my wife A. B. P. Holland all household and kitchen furniture in the house in which I reside. (This clause should have been inserted before the clause disposing of the residue of my estate.
