George Vaughan H^c, Commissioner of the Revenue of this County, personally appeared in court, according to an Act of Assembly passed the 9th day of February 1828, entitled - "An Act amending the several Acts concerning the taxes on Licenses to merchants and others," and complied with the second section of said Act, by stating on oath, that there were no delinquents in this county, under said Act.
