part of that Tract of Land which I bought of my Bro-
=ther Thomas Butt dec. I also give to my Son John
Butt all my Cooper Tools & a Book called a Cooker
only reserving the use of the use of the said Land to my
loving Wife during her natural life and after her

I give and bequeath unto my Grandson Agarish Butt the
land I formerly purchased of my Grandfather Tho^s Butt dec^d with
the Houses and Plantation I now live on only I reserve
the use of the said Land & Houses to my loving Wife during
her natural Life and then I give the use of the said Land
and Houses to my Daughter in law Caren Butt during her
widowhood and if she should Marry then I give the said Land
and Houses to Agarish Butt to him and his Heirs forever.

Item I give and bequeath unto my Grandson John Butt the Son of
my Son Anthony Butt one Negro Man called Coffie only re-
serving the use of the said Negro to my loving Wife during
her Natural Life after her Death then I give the use of the
said Negro Coffie to my Daughter in law Caren Butt
during her Widowhood if she marry then I give the said
Negro Coffie to my Grandson John Butt to him and his
Heirs forever.

Item I give and bequeath unto my Daughter Courtney Hodges one Ne-
gro Girl named Hanah with all her

Item I give and bequeath unto my Daughter Courtney Hodges one Negro Girl named Hannah with all her Increase to act and give her at her own proposall only reserving if use of the said Negro to my loving during her Natural Life

Item I give and bequeath unto my Daughter Roziah Butt one Negro Woman named Lucey with all her future Increase only reserving the use of the said Negro to my my Loving Wife during her Natural life after her Death to her and Heirs for Ever

Item I give and bequeath unto my Daughter Prudence Fourman one Negro Girl named Member with her future Increase one Feather Bed and furniture belonging to it only reserving the use of if said Negro and Bed and furniture to my loving Wife during her Natural Life after Death then to her and her Heirs forever

Item I give and bequeath unto my Daughter Ufan Avery and my Daughter Affiah Wallace one Negro woman named Dinah to be equally divided between them only reserving the use of if said Negro Dinah to my loving Wife during natural life then to them and their Heirs for Ever

Item I give and bequeath unto my Daughter in law Caree
one Looking glass and one Smoothing Iron to her and her heirs

Item I give and bequeath unto my Grandson Azariah Butt one
Black and white heffer to him & his heirs for ever

Item I give and bequeath unto my Grandson Anthony Butt one
Head & white heffer and one Hand Mill only reserving the
use of the said Mill to my loving Wife during her natural life
then to him & his heirs forever

Item I will and desire is that all my Household furniture & Stock of
every kind shall be equally Divided between my Two Daughters
Mara Avery & Prudence Fourman to them and their heirs
for ever if there be any thing left after the Death of my lov-
ing Wife
