Debts and funeral Expenses and after her death my will is that all the Negroes and
their Issues and all the Rest of my Moveable Estate to be Equally divided between
all my children to wit Saml Butt Samuel Butt Enoch Butt Betisha Butt
Lucas Butt and Jeremiah Butt to them and their Heirs for ever ~ ~ ~

Item I Give to my son Samuel Butt the North End of my plantation to him and his
Heirs for ever beginning at a pine on the Branch side and running a line of my
Land to a White Oak joining Samuel Etheridge Land which line is ordered to be
Made by my Brother Lawd Butt and Samuel Butt and Samuel Etheridge

Item I Give and bequeath to my son Enoch Butt the South side of my plantation
to him and his heirs for ever and I Const ~~and~~ ~~in~~ my Well beloved
Wife Amy Butt and Edward Butt my Whole and Sole Executors of my will
This my last Will and Testament in Witness Whereof I have hereunto set my hand
and Seal this Twenty second day of December in the year of our Lord one
Thousand Seven hundred and thirty three
