mouth to be Sold and the money arising thereby after Paying said Col^l. Craford's Bill due to Col^l.
William Craford on acc^t the said Lot of Land I give to my Son John Portlock and his
Heirs for Ever
- Item I give and Bequeath unto my Son Charles Portlock my Land and Plantation I Now Live
on Likewise Eight Acres of Land which I Bought of Tho^s. Williamson which said Land was Ack-
nowledged to Tho^s. Nash & he being to acknowledge the said Land to me when required I give
the said Eight Acres of Land with my Plantation to my Son Charles and his heirs for Ever
- Item I give and Bequeath unto my Daughter Anne Portlock one Bed & furniture one Looking
glass and a Cow and Calf to her and her heirs for Ever
- Item I give and Bequeath unto my Daughter Martha Portlock one Bed and furniture one Look-
ing glass and one Cow and Calf to her and her heirs for Ever

I give and Bequeath unto my Loving wife Martha my Negro man george During
his Natural life and after his decesse I give the said Negro man george to my Son John
and my daughter Martha Portlock to them and their heirs for ever
And as for the Rest of my Estate not before given away I give to my Loving wife
Martha Portlock; and I do Nominate and Appoint my Loving wife Martha
and my Brother in Law Amos Etheridge my whole and Sole Executor and Execut.
of This my Last will and Testament Revoking all Other Wills by me made
