one Negro woman named Sabina, with all her future Increase, to her, her heirs
and assigns forever.
I then I likewise Give & Bequeath unto my loving daughter Ann Carr, aforesaid, one black
one old saddle, one Tea Kettle, one spinning Wheel, to her, her heirs & assigns forever.
I then I Give & Bequeath unto my loving son, Jonathan Godfrey, one Negro man
named Lacey, to him his heirs & assigns forever.
I then I Give & Bequeath unto my loving son, Arthur Godfrey, one Negro girl
named Bridget, with all her future Increase unto him his heirs & assigns forever.
I then I Give and Bequeath unto my loving son William Godfrey, one Negro
Woman, named Abba, with all her future Increase, unto him his heirs & assigns
forever.
I then I Give & Bequeath unto my loving son Daniel Godfrey, one Negro
Boy, named Jack, unto him his heirs and assigns forever.
I then I Give & Bequeath unto Ann Carr, the widow of Edward Carr, the sum of
fifteen pounds Current money of Virginia, provided always, that said Ann Carr,
bring no account against my Estate, but if she does my will is that said Amount
be deducted out of the fifteen pounds Legacy aforesaid.
I then I Give & Bequeath unto James Carr, the son of Ann Carr & widow of Edward
Carr, the sum of Five pounds Current money of Virginia.
I then I Give and Bequeath unto my loving son Lemuel Godfrey one Negro girl
named Judah, & one Negro Woman named Hannah, with all their future Increase
and all the Remainder of my Estate Real & personally, together with said Negroes
Judah & Hannah, I leave to be sold and after payment of my Just debts the surplus
to be paid by my Executors, to my said loving son Lemuel Godfrey unto him his
heirs & assigns forever.
I then my Will and pleasure is that if any of my Children shall die before
they attain to the age of Twenty one years, that their Estate or Estates be divided
amongst my Sons Jonathan, Arthur, William & Daniel & Lemuel Godfreys, and
my Daughter Ann Carr, or such of them as shall be alive at that time to
their heirs & assigns forever.
I then I appoint Mr Samuel Langley of the Borough of Norfolk to be my
Executor of this my Last will & Testament, hereby Revoking & Disannulling
all former wills, by me heretofore made, & declaring this to be my last will
& Testament, In witness whereof I have hereunto set my hand & Seal
this fourteenth day of January in the year of our Lord one thousand
seven hundred & fifty eight.
