 my son William one Negro boy Named Jonas and one Negro Girl named Alice her and her
 Increase to him and his heirs lawfully begotten of his Body for Ever also one feather bed and
 Bedstead with Curtains and other furniture one black walnutt Desk one Church Bible one
 Gun one Cow Called pretty and one young Cow marked Crook and Slits each Ear with
 their Increase also one Sow and piggs one Hand Mill and one large looking glass and
 One pair of Steadyards six Chairs and one Table also one large pot and pot Hooks &
 pot Hangers to him and his heirs for ever

Items. I Give and bequeath to my beloved Daughter Polly White one Negro boy Named Mathew
 and one Negro Woman Named Hanner with her Increase also one feather bed and
 furniture and one Heifer Marked over slope and under heel the right Ear and
 Crook and over heel the left Ear with their Increase also one Sow and piggs Two Smith
 iron Irons and one pair of Pot Hooks to her and her heirs for ever

furniture and one Steyer Marked over slope and under heel the right ear and
crop and over heel the left ear with their Increase also one sow and piggy Two Smith-
ing Irons and one pair of both Racks to her and her Heirs for ever Here
Item. I give and bequeath to my beloved Child that my wife is now big with, the plantation and Tract of
Land belonging to me at Arramistuck joining on the lake containing one Hundred Acres
provided the same should prove to be a Male Child and if not my will and Desire is that
my Daughter Colley White Have the one Half the said Land at Arramistuck and my
will and Desire is that my Daughter Colley and the one that my wife now carries have
six cows and calves at Arramistuck and their Increase them and their Heirs for ever
I also give to my beloved Child that my wife now carries Whether Male or Female
One Negro boy Named Toney and One Negro Girl Named Lydia and her Increase
that and its Heirs for ever

Item. my Will and Desire is that if any of my Children die without lawful Heir or Issue of body
that their Estate be Equally divided Among the Rest to them and their Heirs for ever

Item. I give and bequeath to my well beloved Wife Mary White the one third part of my plantation
whereon I now live with the one half of my Orchard during her Natural life also one Me
Named T. T. and one Named N. N. will is that the Heirs

My wife during life and this my last day During her widow hood and this said day I have to return
as before mentioned also I give to my beloved Wife Mary White one Cow and Threes Larding and
One dry ~~cow~~ one young Cow During her Natural life and at her Death the said
Cattle and their Increase to be Equally divided among my Children, I also Give to my
beloved Wife One young Mare Named Janet Two Stocks of Bee four Ewes one
feather bed and furniture also Twenty five barrels of corn and three barrels of pork
and six Sows and Piggies and one cart and Wheel one Linen wheel and one woolen
Wheel Two Weeding Hoes and One Broad Bar and one Shear Plough one large Disk
One Small Basins and Six plates also three Hogsheads and Two barrels further
Constitute and appoint my Trusty friends Caleb White and Matthias Miller my
Whole and sole Executors of this my last will and Testament Revoking all others
In Witness whereof I have hereunto set my hand & seal this ^{seventh} ~~eleventh~~ day
of October one Thousand Seven Hundred and seventy three
