cently buried and then I desire all my just Debts to be honestly
paid and then fulfilled as followeth —

Item I give and bequeath to my Cousen Caseby Coats one hundred
Acres of Land joining upon Henry Haewes line after her fa-
ther's decease it being the Plantation he now lives on to her
and her heirs forever —

Item I give to Mr. Miller one Negro boy called Martin to him & his heirs forever

Item I give and bequeath to my Cousen James Coats one Negro Boy called
Abraham to him and his heirs forever —

Item I give & bequeath to Elenor Godfrey and Eliz^a Godfrey one Negro Girl called
Rose to be equally divided between them after the death of Matthew Godfrey
and all what is due to them and their heirs forever —

Item I give and bequeath to my Cousen Willis Coats one Negro Boy called William to him and his heirs forever.

Item I likewise give and bequeath to my Cousen Caleb Coats one Negro Boy called Matthew to him and his heirs forever.

Item I give and bequeath to my Cousen Richard Coats one Negro Boy called Sam to him and his heirs.

Item I give and bequeath to my Cousen Malachi Coats one Negro Girl called Betty to him and his heirs.

Item I give and bequeath to my Cousen Eliz^a Coats one Negro Girl called Loney to her and her heirs.

Item I give and bequeath to Matthew Godfrey fifty Acres of Cypress Swamp joining on the Land whereon I now live.

Item My Will and desire is that my Negro Man Afa and Nell his wife should have the use of one half of my Plantation and Land during their lives and after their decease and then I give the said land to my Cousen James Coats the one half on left I leave to him at my decease.

Item I also give to my Negro Man Afa & Nell one Cow & half ten head of Hogs.

Item I also give and bequeath to Mrs. Miller one old gun to be his heirs.

Item I also give and bequeath to Wm Miller one old Gun to be his forever.

Item My Will and desire is that Josiah Wilson should have my Negro Man Roten and to pay four pounds Virginia Money yearly and find him cloaths and pay his Levy and the Money to be equally divided between all my Cousens James & Willis & Caleb & Malachi Coats.

Item My Will and desire is that all my stock should be sold and all other Moveables belonging to me to the highest Bidder and after my debt is paid the remainder part of the Money to be for George Coats and if my Negro Wench Nell should have another child my Will & desire is that George Coats should have it and so forth.

I leave Matthew Godfrey and William Miller Executors of this my last Will and Testament & annulling all other Wills & allowing this to be my last Will and Testament, whereof I have hereunto set my hand and fixed my Seal this 9th day of June in the Year of our Lord God 1759.
