me I Give and Dispose thereof in manner and form following

Item I Give and bequeath unto my Son Spring Cherry the plantation and Land I now Live on containing
fifty acres with all the Conventances thereunto belonging to him and his heirs for ever also one hundred
and five acres of Swamp Land I Give the S. Spring Cherry to him & his heirs for ever

Also I Give unto my Son Spring Cherry my old plantation and Land Down to the Road the S. plantation
I formerly Live on to him and his heirs Lawfully begotten of his body for ever

Item I Give and bequeath unto my Grandson Jonathan Cherry the Remainder part of the Land Lying below
the Road which Did belong to the S. old plantation Land the S. Land joyning upon Deep Creek
to him and his heirs for ever and the Road to be the bounds between my Son Springs Land & my Gran-
son Jonathans Land x x x x x

Item I Give unto my beloved wife Sarah Cherry one Cow & Calf and one Sow and piggs and Three pounds in
Money to her and her heirs for ever

Item I Give unto my Granddaughter Vfan Cherry one heifer to her & her heirs for ever

Item I Give unto my Son Spring Cherry my hand mill Stones and one feather bed and the furniture
thereunto blonging the S. bed which I Lay on to him and his heirs for ever

Item I Give unto my Doughter Bethia Cherry one feather bed & the furniture belonging to it and one

small iron pot and the half of my pewter and one Cow and one Stock of bees to him & his heirs for Ever
Item I Give unto my Son Spring Cherry one Large Iron pot and my mare and the other half of my pewter
which I have not Already Given before and one Large Chest and one Cross cut Saw to him & his heirs for Ever
Item I Give unto my Granddaughter Ann Cherry one heifer to him and his heirs for Ever
Item I Give unto my Grandson Joel Cherry my new Gun to him & his heirs for Ever
Item I Give unto my Son Spring Cherry all my Copper Tools and all the Remainder part of my Chattle that
I have not Already Willd. away to him and his heirs for Ever
Item I Give unto My Daughter Elizabeth Cherry Twenty Shillings and that to be in full of his portion
Item I Give unto My Son John Cherry Twenty Shillings and that to be in full of his portion
Item I Give unto my Son Aaron Cherry Twenty Shillings and that to be in full of his portion
Item I Give unto my Daughter Asa Hill Twenty Shillings and that to be in full of his portion
Item I Give unto my Daughter Bethia Cherry one Large Table for Ever
Item I Give all my Stock of hogs to be Equally Devided between my Son Spring Cherry & my wife
Sarah Cherry & my Daughter Bethia Cherry allso all my money which I have not Already
Willd. away I leave to be Equally Devided between my Son Spring my ~~Wife~~ wife Sarah and
my Daughter Bethia paying my funerall & Coart Charges: And I Do hereby Constitute and
Appoint my Son Spring Cherry Sole Execut^r & Exetrix of this my Last Will and Testament Revoke-
ing Disavowing and making Void all former Wills by me made and this only to be taken for my Last
Will and Testament In witness whereof I have hereunto Set my hand and Seall this Thirtieth
Day of April one Thousand Seven hundred and fifty four
