

In the Name of God, Amen. I John Grant Senr
of the County of Norfolk, being sick and weak in Body, but
of sound Mind and Memory Thanks be to Almighty God, do make
and ordain this to be my last Will and Testament, in manner and
form following.

Item I give and bequeath unto my Son John Grant the Plantation now
I am possessed with being Seventy Five Acres more or less -
during his Natural Life; After his Death I give the said
Plantation to my Grandson John Grant. to him and his Heirs
forever. But if my Son John Grant should have a Son law-
fully begotten of his Body, I give my said Plantation to him
and his Heirs forever. I give unto my Daughter Bridget Grant
the Bed and Furniture that now she lies on to her and her Heirs
forever. I give unto my Daughter Ann Cooper the high
Bed and Furniture that I now Sleeps on to her and her Heirs
forever. I give unto my Son John Grant, the Bed and Furniture
that he and his Wife now Sleep on, to him and his Heirs forever.
Also I give him my Hand Mill to him and his Heirs forever.
I give unto my Grand Daughter Mary Grant my large black
Heifer to her and her Heirs forever. I give unto my Daughter

in Law, Mary Grant the House she now lives in her life
as long as she lives a Widow, but not to cut, nor clear, nor sell
any Timber, I leave all my cattle to be equally divided among
my children as follows, John Grant, Bridget Grant, Elizabeth
~~Grant~~ Williams and Ann Cooper. My Old Horse is to stay up-
-on the Plantation for the good of it. I leave all my Fur-
-niture within my House to be equally divided between my Son
John Grant and my Daugh^r Bridget Grant I give unto my Son
John Grant Two Sows, and the rest of the Hogs to my Daugh-
-ter Bridget Grant.

I do hereby make and appoint my Son John Grant and my
Daughter Bridget Grant full and Sole Executors of this my
last Will and Testament; hereby Revoking, disannulling, and
making void all former Wills and requests by Me made: and de-
-claring this only be my last Will and Testament.
