Wants to be to the Almighty God I do this the second Day of December
and in ^{the} year of our Lord One Thousand Seven hundred and Sixty
Eight do make and ordain this my last will and Testament in the
following manner

1st I give and bequeath unto my son Joshua Jolloff my Plantation where
I now Live with all the Appurtenances thereunto belonging
except forty Acres of the same that I shall hereafter name
and give unto my son James Jolloff I also give unto my son
Joshua Jolloff my great Table

2^{ndly} I give and bequeath unto my son John Jolloff fifty Acres of
Land that I bought of Aaron Boulton to him and his Heirs forever
but if my son John Jolloff should have no Issue then the
said Land to my son James Jolloff and his Heirs forever I
give unto my son John Jolloff one Negro Girl called Pa-
tience to him and his Heirs for ever

3^{rdly} I give and bequeath unto my Son in Law James King five
Shillings Sterling

Eight do make and ordain this my last will and Testament in the following manner

1st I give and bequeath unto my son Joshua Joloff my Plantation where I now live with all the Appurtenances thereunto belonging except forty Acres of the same that I shall hereafter name and give unto my son James Joloff. I also give unto my son Joshua Joloff my great Table

2^{ndly} I give and bequeath unto my son John Joloff fifty Acres of Land that I bought of Aaron Boulton to him and his Heirs forever but if my son John Joloff should have no Issue then the said Land to my son James Joloff and his Heirs forever. I give unto my son John Joloff one Negro Girl called Patience to him and his Heirs for ever

3^{rdly} I give and bequeath unto my Son in Law James King five Shillings Sterling

4^{thly} I give and bequeath unto my son James Joloff fifty acre of Swamp Land lying between Williams Boultons Land and James Lockers Land But in default of Issue I give the said Land to my son John Joloff

5thly I also give unto my Son James Jolloff the said forty acre
that I accepted of the Land whereon I now dwell to my Son James
and his heirs for Ever. also I give unto my Son James Jolloff
one Negro girl Named Charity to him and his Heirs for Ever.

6thly I give and bequeath unto my Daughter Judith Jolloff one
Negro girl named Annes one Feather Bed and furniture
one Cow and Lamb and forty Shillings cash.

7thly I give and bequeath unto my loving Wife Judith Jolloff
the Thirds of my Land whereon I now dwell and my dwell-
ing House Kitchen and Barn and the rest of the out Houses
during her Natural Life also I give to my loving Wife
one Negro Man Named Archer and also one Negro Woman
Named Diniak during her Natural Life
also one Bed and furniture and Glass and botten and all the
cloth that is in the House that is spun and wove and the
Money that my Wife now has with her in the House also
I give unto my loving Wife the Third part of my Estate within
Dores and without of what kind soever that I have not give-
n away to her during her Natural Life.

I give the remaining part of my Estate that is not already
given away to my Four Children Joshua Jolloff John Jol-
-loff & James Jolloff & Judith Jolloff to be equally divided
among them four also it is my Will and desire that my Es-
-tate shall be only Invented and not appraised but be divid-
-ed among my Wife and Children by any Three Men that my
Executret shall appoint hereafter named.

Furthermore that this my Will is that if my Son Joshua
Jolloff Will or Do or make any Demur concerning that that
Land aforesaid given to my Son James Jolloff to take it away
my will that he shall forfeit the worth of the Land in actual
Cash Arbitrated by any Three Indifferent persons to be
recovered in any Court of Records.

I do Substitute and appoint my Two Sons Joshua Jolloff &
John Jolloff to be my whole and Sole Executors of this my
last Will & Testament in Witness whereof I have hereunto
