all the rest of my Estate to be sold for to pay my Debts
and What is Left to be Equally Divided Among ^(being) all my Children
and this I do own to be my last Will and Testament
and do revoke and disannul all former Wills by me
in any Way made and do ratify allow and confirm
this and no other to be my last Will and Testament
In Witness whereof I have hereunto set my hand
and Affixed my seal the Day and year first before
Written.
