

In the Name of God Amen I Rezinah Godfrey of the County
of Norfolk in Virginia, taking to my most serious considera-
-tion of this Life, being sound in Mind, but labouring under
great Infirmities of Body, do make this my last Will &
Testament in the form & manner following Viz.

Imprimis, I give & bequeath to my Nephew Matthew Godfrey
when he arrives at the Age of Twenty one years, the follow-
-ing Negroes, Will, Kate, Valentine, Newport, & Child Brid-
-get, to him & his Heirs forever.

Secondly. I give & bequeath to my Nephew William Godfrey when
he arrives at the age of Twenty one years, the following
Negroes, Betty, Jeffry, & Ned, the Son of Kate, to him &
his Heirs forever.

Thirdly. I give & bequeath to my Niece Katy Godfrey the follow-
-ing Negroes, Pegg, John, Josy, & Bely, to her & her Heirs
forever.

Fourthly. I give & bequeath to my Sister Aphiah Wyncott one
Negro Woman named Maria to her & her Heirs forever.

Fifthly. I give to my Sister Dinah Archer one Negro Girl
named Phillis, during her life only & at her decease

Negroes, Betty, Jeffery, & Ned, the Son of Ratz, to him & his Heirs forever.

Thirdly. I give & bequeath to my Niece Ratz Godfrey the following Negroes, Pegg, John, Josy, & Cely, to her & her Heirs forever.

Fourthly. I give & bequeath to my Sister Aphraah Worycott one Negro Woman named Maria to her & her Heirs forever.

Fifthly. I give to my Sister Donah Archer one Negro Girl named Phillis, during her life only, & at her decease to go to my Nephew William Godfrey & his Heirs forever.

Sixthly & lastly. I give & bequeath to my loving brother Matthew Godfrey the remainder of my Negroes & all my Estate Real & Personal of what nature or kind soever, to him & his Heirs forever, the Negroes before given away excepted.

I also appoint my Brother Matthew Godfrey the Sole Executor to this my last Will & Testament; In Witness whereof I have hereunto set my Hand & affixed my Seal, this Eleventh Day of June in the Year of Lord One Thousand Seven Hundred & Seventy & Seven.
