Manner and form following to wit,

Here I give and bequeath unto my son Malachi
Withins fifty Acres of Land Adjoining Arthur With-
ins land and John Hodges Also one pair of Hens
& scales to him and his heirs for ever

Here I give and bequeath unto my son Robert Withins
the Plantation whereon I now live and one
half of the Land; Not all Ready given one hand
gun and one hand mill to him and his heirs for
ever

Here I give and bequeath unto my son Richard
Withins all the Rest of my Lands which is on
given Adjoining of John Hodges Land Also one
Negro Child The first that My Negro woman
Fairer Brings to be a girl to him & his heirs
for ever

Here I give and bequeath to my Loving wife Cate With-
ins one Negro man Named Joseph and one
Bed and furniture during her Natural life

Here I give and bequeath unto my son John Withins
one Cow and Calf my will is that my wife
Cate Withins shall give my son John Withins
one year and half schooling

Here I give and bequeath unto three sons Henry
withins Jacob Withins & Dorset Withins a
one Negro man Joseph to be Equally divided
between them all three after my wife de-
ceases

Here I give to my Loving wife Cate Withins all the
Remainder part of my Estate on given without
doors and within doors during her life or wid-
owed and her heirs or managed to be Equally

I give and bequeath unto my son Mabel
Within fifty Acres of Land Adjoining Arthur Wilk-
ins land and John Hodges Also one parcel Mary
scotes to him and his heirs for ever

Here I give and bequeath unto my son Richard Wilkins
the Plantation whereon I now live and one
half of the Land, Not all Reday given one hand
gun and one hand mill to him and his heirs for
ever

Here I give and bequeath unto my son Richard
Wilkins all the Rest of my Land, which is on
given Adjoining of John Hodges Land Also one
Negro Child the first that the Negro woman
Fairer Bring to be a year old to him and his heirs
for ever
I give and bequeath to my Loving wife Cate Wilk-
ins one Negro man Named Joseph and one
Bed and furniture during her Natural life

Here I give and bequeath unto my son John Wilkins
one Cow and Calf my will is that my wife
Cate Wilkins shall give my son John Wilkins
one year and half schooling

Here I give and bequeath unto three sons Henry
within Friedrich Wilkins & Dorstis Wilkins a
one Negro man Joseph to be Equally divided
between them all three after my wife de-
ceases

Here I give to my Loving wife Cate Wilkins all the
Remainder part of my Estate on given without
doors and within doors during her life or wid-
edhood and her de or managed to be Equally
divided between my three sons Henry With-
in Friedrich Wilkins and Dorstis Wilkins
Turn over

To them and their heirs for ever - -
 And I do Appoint my Loving wife Kate Within
 My hole and sole Exeute of this my Last will
 and Testament as Witness my hand and seal
 this seven th day of October 1799
