my Land lying on the Southwest Side of the new Spring Branch containing One hundred and thirty Eight ac-
more or less with the Cypress Swamp adjoining to it To have and to hold unto him my said son Caleb and
Heirs for Ever I Give and Bequeath unto my said son Caleb two hundred Acres of Land more or less
and being on the Indian Creek and on the South Side of a line of marked Trees to him my said son & his Heirs
Ever also one half of the Chattles thereunto Belonging, also One Negro Boy named Brum, also my son
Still and all Utentials belonging to it also a young Bay Horse thats now in the care of Benjamin Mason to
my said son Caleb White all the above said Legacies to him and his Heirs for Ever.
I Give and Bequeath unto my son Nedar White One hundred Acres of Land I Bought of Colonel Henry White
Binding on the Herring Run with the Cypress Swamp on the North Side of Poquetty Bridge, also two
hundred Acres of Land more or less lying and being on the Indian Creek and on the North Side of
Trees also one half of the Chattles thereunto Belonging also my Water Mill and all Utentials, also one Negro
named Charles to him my said son Nedar the above said Legacies to him & his Heirs for Ever.
I Give and Bequeath unto my son Gideon White my Plantation and Tract of Land whereon I now live with all
Appurtenances thereto belonging, adjoining on the Herring Run and the Cypress Swamp adjoining also
I Give unto my said son Gideon One hundred Acres of Land at Aramisheet whereon my house stands, also I Give
unto my said son Gideon one Negro woman named Hanner and four negro boys named Joney, Matthew, Silas and
and Jonas, one large Mill two Beds Bedsheads and furniter one with Curtains and Valens one Church bible
large iron Pot and one Small one and two pair of pott Trammels, also all the iron work belonging to my house and
tion except one iron pot, also I Give unto my said son Gideon all my stock of hogs Except three sows and pigs
Each of my Daughters (Viz) Fiza Bush and Lydia White, also I Give unto my said son Gideon one large
Glass one Buck near Gun and one Small Gun, one mare named Phoebe one Colt named Silver also one
horse named Gamister one Bridle Saddle and harness also one Colt at Aramisheet and four head of Cattle
One frying pan and one young Cow where I now live. And all my wearing Apparels, also I Give unto my
son Gideon all my Crop of Corn that is now upon the ground, also one peck of hard Inditions, also
Linen what, also one woolling wheel, also I Give unto my said son Gideon one half of the Iron Tools
Aramisheet to him my said son Gideon the above said Legacies to him and his Heirs for Ever
But Provided my said son Gideon should die under age, then the plantation whereon I now live to descend
my son Caleb White, to and my plantation at Aramisheet to descend to my son Nedar White To them
their Heirs for Ever. My will and desire is that my son Caleb

My will and desire is that my son Gideon White shall pay unto my Grandson Patrick Miller Ten pounds
Cash when the said Patrick attains to the age of Twenty one years -
I give and Bequeath unto my Daughter Amey Reddys one negro Girl named Peggy and her Increase also one
hundred and Twenty five acres of Land out of my Tract at Arrimuskeet to her and her heirs Lawfully
begotten of her Body for Ever. Also one Bed and furnituer and one pair small Milliards to her for Ever
I give and Bequeath unto my Daughters Prudence Miller Kezia Butt and Lydia White all my unmen-
tioned Lands at Arrimuskeet to be Equally Divided Between them and to them and their heirs for Ever
I give and Bequeath unto my Daughter Prudence Miller one Negro girl named Nan and her Increase to her and
her heirs for Ever.
I give and Bequeath unto my Daughter Kezia Butt one Negro woman named Len and her last Child named Sam
and all her Increase also one looking Glass one white Mare named Spry to her and her heirs for Ever
I give and Bequeath unto my Daughter Lydia White one Negro Girl named Koffie and her Increase also one
small horn Bull. My will and Desire is that my son Gideon White shall pay unto my Daughter Lydia
Twenty five pounds Cash to her and her heirs for Ever.
I give and Bequeath unto my Grand Daughter Lydia Wilson five Shillings it being in full of my Estate
I give and Bequeath unto my Daughters Prudence Miller Kezia Butt and Lydia White all my wife
wearing Apparell to be Equally Divided Between them
I give and Bequeath unto my two Daughters Kezia Butt and Lydia White to Each of them four head
Cattle Out of my Stock at Arrimuskeet and New Coroluck. And then the whole and Sole of my
unmentioned Estate to be Equally divided amongst all my Sons and Daughters and for the true
performance of Every part matter or thing Contained in this my Last Will and Testament
do hereby appoint and ordain my son Caleb White and John Butt to be my whole and Sole
executors of this my Last will and Testament, And do Leave my son Gideon free himself at my death
And to have all his portion paid as soon as matters Can Be settled and for the true performance hereof I leave
hereunto set my Hand and affixed my Seal this 17 day of October Annoque Domini 1761
