

In the Name of God Amen. I Peter Bull of the County of Norfolk and Parish of St. Brides being in a low state of health but of sound sense and memory do make this my last Will and Testament as follows -

Imprimis I leave the use of the Houses, Land & Plantation wherein I now live to my loving Wife Keriah during her natural Life, I also leave the use of the following Negroes to wit Luacco, Susah, & Lucy to my loving Wife Keriah during her natural Life on condition of her keeping my son Peter Bull during her Life; in case my son Peter Bull should survive my loving Wife Keriah, I then leave the use of the above Negroes to wit Luacco, Susah & Lucy to my son Peter Bull during his natural Life, and after the death of my Wife Keriah and my son Peter, I then give and bequeath the said Negroes to wit Luacco, Susah & Lucy to be equally divided among my sons Trimmer Bull & Henning Bull and my Daughters Peggy Bull & Keriah Bull to them and their Heirs forever.

Item. I give and bequeath to my son Trimmer Bull, the Land and Plantation wherein I now live (after the decease of my Wife Keriah) to

Item. I give and bequeath to my Son Trimmagin Bull, the Land and Plantation wherein I now live (after the decease of my Wife Keiah) to him and his Heirs for ever. I also give to my Son Trimmagin Negro Boy Eden, and Negro Girl little Judah, my Mill, one Gun called his, one Bed of furniture, one Horse called Carver, and one Saddle, to him and his Heirs for ever.

Item. I give and bequeath to my Son Henning Bull the Land and Plantation which I bought of Thomas Carson to him and his Heirs for ever. I also give to my Son Henning, Negro Manch Kate, Negro Boy Mapey & Negro Boy Sam, one feather Bed of furniture, one Gun, one Horse called Spark, one Saddle & Bridle, and all the Blacksmiths Tools, to him and his Heirs for ever.

Item. I give and bequeath the Land & Plantation adjoining the Pocason which I formerly bought of Edward Haynes to be equally divided between my two Sons Trimmagin and Henning to them and their Heirs for ever.

Item. I give and bequeath to my Daughter Peggy Negro James, a Negro Girl Violet & Negro Boy Jonas, one feather Bed and furniture called her Bed, one Cow & Calf, two Ewes & Lambs, and one Chest, to her and her Heirs for ever.

Item I give and bequeath to my Daughter Keriah Negro Wench Suky and Negro Boy Bob, one feather Bed of furniture, one Chest, one Cow and Calf, and two Ewes & Lambs, to her and her Heirs for ever.

Item. I leave the use of all my household and kitchen furniture, Plantation utensils, and stock of all kinds to my loving Wife Keriah during her Life, and after her Death to be equally divided among my Sons Trimmagin & Henning and my Daughters Peggy & Keriah to them and their Heirs for ever.

Item. I give and bequeath what money may be left after my debts are paid to be equally divided among my loving Wife Keriah, my Sons Trimmagin & Henning and my Daughters Peggy & Keriah to them and their Heirs for ever.

Lastly I nominate and appoint my Loving Wife Keriah to be Executrix and my Son Trimmagin Full Executor of this my last Will and Testament hereby revoking and disannulling all former Wills made by me.

is granted her to be joined in the probat of the said Will.
