ever. I Give Ninety two Acres of Cypress Swamp at the South end
to her and her Heirs forever; I Give one Negro Boy called John to her
and her Heirs one Bed and furniture two Cows & Calves to her and her

Mare and one oval Table I Give to her & her Heirs.
I Give ^{my} to my loving Wife Abigail Butts During her Natural Life

One Negro Woman Pleasant and after her Decease to my Daughter
Elizabeth Butt and her Heirs I do give all my Remainder Estate
to my Wife after paying all my Debts to her own Disposall and
for the Management of my Estate. I Do appoint my Loving Wife
my whole and Sole Executor of this my Last Will and Testament
I here do set my Hand and Seal this 7th Day of January 1765
