 to him my S^r Son his heirs & assigns for ever I give unto my S^r Son Maj^r Samuel Bouffé
 my best horse bridle & saddle also my new black cloak being in full consideration
 his Part or Portion of my Estate. I do appoint y^e my loving wife to be well provided for
 out of y^e Profits of my Estate during her natural life. I give unto Mrs^s Mary Miller &
 Mrs^s Margaret Moore them a black suit of Cloaths according to y^e direction of
 my Executor. I give unto a
 Land & Negroes I shall be p^r above mentioned given to me
 for ever & for want of such a Son Goodrich Bouffé & if he be
 William Bouffé & his male Heir of Personals Capt with a
 seven my silver hilted sword with all at y^e time of my decease
 Rings & my silver snuff box I desire my S^r & my Son to be
 of the Church of England & to be
