having regard to an Agreement made between John Stevens Esq and myself
if the said Stevens shall not choose to purchase the Estate belonging to me according
to the Terms of our Agreement then it is my Will and desire that my Executors
James Boyce and Robert Threlfall may sell and dispose of all my Estate in the West Indies
at publick Sale giving a reasonable time for payment on the purchasers giving bond
and good Security. And it is my Will and desire that all my Estate Real and
personal lying and being in Virginia or else where, other than the West Indies may
be sold by my Executors Paul Loyal William Smith and Henry Brierly afore-
mentioned or the survivors or survivor of them in such manner as to my said
Executors shall seem most for the benefit of my Estate

Item I give and bequeath the Money arising by the sales of my Estate after payment of
my just Debts Funeral Expenses and Charges of Settlement of my Estate to be divided
in the following manner that is to say one fifth part thereof to my Sister Mary
Loyal, one fifth part thereof to my Sister Elizabeth Corpe, one fifth part thereof
to my Nephew James Boyce the only Child and representative of my Sister Barbara
Boyce Deceased one other fifth part thereof to my the Children of my Brother Robert

With Power to execute the same in the same manner as if no other Person had
been appointed Executors hereof. And I further Declare my Will is that as the
Principal part of my Estate is in the West Indies) that after payment of said
Nephew James Boyce's Legacy the residue of the proceeds of my Estate shall be my
