distributary share of my estate in total bar and preclusion of any other
further present or future claim to the same - Item I give and bequeath to
my other Children Viz Franklin Gastin and Nancy together with Charles
son by Suez Richardson Alias Suez Halson (who was delivered of my son
Charles in my house the tenth day of November one Thousand Seven Hundred
eighty eight and is now living with his mother Suez who manages my house
and business in the Capacity of my house keeper) all and every part of my
estate both real and personal to be equally divided among my Last
mentioned Four Children each of which to receive their allotment or distributary
share of the same as they arrive to the age of twenty one years or in any of the survivors
