Will

In the name of God Amen. I Mary Dupuy Widow of John
B. Dupuy of Notkowsy lawfully being sick but of sound and disposing mind
and Memory do make this my Last Will & Testament in manner as follow-
following: First I Recommend my Soul into the hands of Almighty God that
gave it and my Body to the Earth to be buried in such decent Christian
like way as my Executors hereafter Named may think proper.

Item I give unto my Nephew Milton Ford my Negro Woman Named Nancy
and ^{her} future Increase to him and the Lawfull Heirs of his Body forever.

Item I give unto my Nephew Samuel Ford my Negro Boy Charles to him and the
Lawfull heirs of his Body forever.

Item I give unto my Nephew Waller Ford my Negro Girl Amy my Negro Woman
Rachel & her child Named Milton & the future increase of the said Amy
& Rachel to him and the Lawfull Heirs of his body forever. I also give him
my Black Horse and my Yoke of Oxen which I Bought of my said Nephew
to him and his heirs forever.

Item I give unto my Niece Mary Weston my Negro Girl Patty and her future
increase to her and the Lawfull heirs of her Body forever.

Item I Give unto my Niece Lucy Manges my Negro Girl Abby and her future increase to her and the Lawfull heirs of her Body forever.

Item I give unto my Niece Ann Ford my Negro Boy Elijah to her and the Lawfull Heirs of her Body forever.

Item I give unto my Nephew ~~Thomas~~ ^{William} Mays my Negro Woman Betty and her Child Mary and her Child Manning & Lucy my Negro Man Peter my Negro Woman Lucy her Two Children Fanny & Rosiah to him and the Lawfull Heirs of his body forever.

Item I give unto my Nephew Robert Giers my Negro Boy Mameo Sam to him and his Heirs Lawfully Begotten forever. Also my Yoke of young Oxen

Item I give unto Anne Oliver (Daughter of John Oliver deceased) my Negro Boy Gary and ^{to} Appoint my Nephew Walter Ford as Guardian to the said Anne Oliver and do direct him to hire out the said Negro Gary privately and the profits arising from his hire to go to the support of Anne Oliver at the Decease of her said Guardian and of any thing over and above supporting her it is to be paid by her Guardian to her when she Marries or becomes of Age.

Item I give unto my Nephew Christopher Hearn one Feather bed & Furniture & three head of Cattle

Item I send unto my Niece Betty Ford & Cousin One Feather Bed & Furniture and three head of Cattle during her Natural Life

and three head of cattle during her Natural life and at her death
I Give the same to Christopher Legarett

Item I Give unto my Nephew Zachary Ford my Negro Girl Named Tabitha and
her future increase to him and the Lawfull Heirs of his Body forever

Item All the Residue of my Estate not already Disposed of by this my Will I
Direct to be sold and the Money Arising from the said things to be applied
to the Use of Lewis Fords Children to whom I Give the same.

I Also direct that Every One to Whom I have Given a Legacy of a Negro
to at the time of their Receiving the said Legacy or Legacies pay unto
my Executors Three pounds Specie Each which said Money I direct my
said Executors to lay out in best Manner they think proper for the benefit
Profit & Use of my Nephew Lewis Fords Children whom I Give the same to

Item Where I have given a Legacy of a Negro my intent and meaning is only to
lend it During their Natural lives. and it is my desire that no Legatee
have the privilege of Disposing of or Hiring any Negro Bequeathed
by this my last Will. as I do only lend it to them during their Natural
lives & Give it to their Children

And lastly I constitute and Appoint my Nephews Waller Ford & Samuel
Ford Executors of this my last Will & Testament Revoking and
making void all former Wills by me made as Writings my hand and
Seal this Twentieth day of March 1793

And after paying all my Just debts, The balance of money arising from such Sale I give and bequeath unto Fanny Elizabeth daughter of Jada directed to be set Free above, But if the
