In Obedience to an Order of Orange County Court the Subscribers
 named therein for the purpose, have proceeded to divide the
 Land and Slaves belonging to the Estate of the late Thomas
 Morrisson deceased amongst the Children and Legatees of
 the said Morrisson, to-wit: John, George, Bogwell, Thomas
 as following the Land containing three Hundred fifty five acres
 a house of 25 acres held in fee at that time by Adam Goodlett
 was equally divided by Survey made by Richard C. Webb
 Surveyor of the County into four Lots of 88 1/4 acres each the
 Legates having drawn ~~the~~ in the usual way by Richard
 George Morrisson drew the Lower Lot including the Land
 adjoining Francis Hughes, Bogwell the next adjoining, John
 the third & Thomas the fourth or upper Lot. The Tract
 lying in a long square is divided by lines from the mountain
 down to the black line by lots numbered or to be numbered by
 the Surveyor - The Negroes as follows
