both Real & Personal (after my just Debts are paid) shall be
Equally Divided Between my beloved Wife Francis Banks &
my Child which she is now with Child of be the same male or
female & I do by these presents Give & Bequeath my s^d Estate both
real & Personal to them the s^d Francis & the s^d Child to be Equally
Divided Between them Both to them & the Heirs of their Bodies Lawfully
begotten forever and in case my Child which is now with me is now

Item my Desire is that all my other Lands & all my other Estate both Real & Personal (after my just Debts are paid) shall be Equally Divided between my beloved wife Francis Banks & my Child which she is now with Child of the the same male or female & I do by these presents Give & Bequeath my sd Estate both Real & Personal to them the said Francis & the said Child to be Equally Divided between them both to them & the Heirs of their Bodies Lawfully Begotten forever and in case my Child which my Beloved wife is now with should die without Heir of its Body Lawfully Begotten then it is my desire that its part of my Estate should depend to my Beloved wife it is also my will & Desire that if my Beloved wife should die without Heir of her Body Lawfully Begotten (other than that which she is now with Child of) that then her part of my Estate to return to my said Child which she is now with & farther it is my will & Desire that in case my said wife & Child & all the Heirs of their Bodies should Decease that then all my estate both Real & Personal shall Devise to & remain to the said the mother

of said wife with other things for and with my executors
to Deed to my loving brother William Banks and to the heirs of his body lawfully
by him or his heirs and for want of such heirs to my brother Peuben Banks
Heirs. I do hereby appoint my loving brother Linn Banks and my beloved
wife Francis Banks Executors of this my last will & Testament
Revoking all other wills as witness my hand and that the 9 day of

This will was produced into Court by Wm Pennell with a note from the Exors who
declared they would not act as atts but they were willing that Deeds Thomsen
should admit upon the s^d Estate of the Gerard Banks and this will was

the witnesses thereto and ordered to be Recorded
