54 one part and ROBT. & ARCHIBALD WILSON of said County of other part Witnesseth that in consideration of the uses and Trust hereinafter mentioned and for sum of Five shillings hath sold unto the sd Robt. & Archibald Wilson their heirs in trust of the use hereafter mentioned two male Slaves Vizt. one by the name of Jack the other Ned To hold the Slaves on the following terms that Ludwell Grymes is Justly indebted to the sd Robert and Archibald Wilson's the sum of Sixty pounds two shilling and seven pence of the present current money of Virginia and whereas the said Ludwell Grymes is also justly indebted to WILLIAM ALCOCK of the same County in the sum Eleven pounds Three shillings and nine pence current money as aforesaid and in case the said Ludwell Grymes pay the sd Sixty pounds two shillings and seven pence unto the sd Robt. & Archibald Wilson with Legal interest also the said sum unto William Alcock with legal interest from the 21st day of May last on or before the first day of May next ensuing that in that case the Slaves shall be
