

I Stephen Holland of the County of Pennsylvania and State of Virginia for being of sound and disposing mind and memory do make and publish this my last will and testament hereby revoking all former wills by me at any time heretofore made.

Imprimis My will is that all my just debts and funeral charges shall by my executor and executor (hereinafter named) be paid out of my estate as soon after my decease as shall by them be found convenient.

Item I give and bequeath to my beloved wife Lucy Holland during her widowhood all of my estate both real and personal consisting in part of land negroes horses cattle hogs sheep household and kitchen furniture the crop of every description that may be on the plantation and all the provisions that may be on hand at my death all debts due by me or account with the exception of particular debts that may be hereinafter named, but provided she the said Lucy Holland does marry again then it is my will and desire that she shall have only one third part of my estate for and during the term of her natural life.

Item It is my will and desire that my beloved daughter Sarah Holland shall, provided she remain single live with my said wife Lucy Holland and be decently supported out of my estate during the widowhood of my said wife Lucy Holland and at the termination of the widowhood or death as the case may be of the said Lucy Holland I will and bequeath to her my said daughter Sarah Holland provided she remain single the sum of \$15000 with interest.

Item provided my said wife Lucy Holland marries again then the

~~then it is my desire that at her death all of my estate with the exception~~
of the above mentioned debts shall be equally divided between all
of my children above named. But if she the said Lucy Holland shall
marry again then at her death it is my will and desire that all of that
portion of my estate that I have willed her for the term and during her
natural life as her dower shall be equally divided between all of my
children above named.
