My will and desire is that my Negro Woman Phillis may be sold in some of the other Counties in Virginia and I give the money she shall for together with following Slaves vizt Ben Lancashire and following Slaves to be named of to wit.

I give and bequeath to my Vice Phillis a sum of money to be paid for when she attains to the age of Eighteen and shall marry and if she dies before either the aforesaid Slaves to be named to her heirs forever.
