 Wm Davis & receipt whereof he said Wm Davis hereby acknowledge & convey part of parcel thereof
 & doth acquit & discharge him & said Daniel Glasgow Jun. his heirs Ex: adm: assigns for ever
 and by these presents doth give grant bargain & sell on foot & confirm & by these presents have given
 granted bargain & sold unto Daniel Glasgow his heirs Ex: adm: assigns and certain parcel
